

Terms and conditions of the paid referral program of Taxcoach sp. z o.o.

I. Definition of what is understood as a “Client referral” under this program

A “Client referral” means providing a potential new Client of Taxcoach sp. z o.o. with the contact details of the above-mentioned company for the purpose of concluding an agreement for the provision of accounting services by Taxcoach sp. z o.o. to the new Client.

II. Who may become a participant in the referral program?

1. The program is open to all entities that recommend the services offered by Taxcoach sp. z o.o. to a potential new Client.
2. Participation in the program constitutes acceptance of these Terms and Conditions, which define the rules of the program.

III. Rules for providing contact details/recommendations under the paid referral program

1. The program participant provides a potential new Client of Taxcoach sp. z o.o. with the contact details of the above-mentioned company for the purpose of concluding an agreement for the provision of accounting services by Taxcoach sp. z o.o. to the new Client. At the same time, the program participant shall promptly inform Taxcoach sp. z o.o. that a recommendation has been made to a specific potential new Client.
2. The potential new Client contacts Taxcoach sp. z o.o. in order to conclude an agreement with the above-mentioned company for the provision of accounting services to that Client.
3. During the contact referred to in section 2 above, the potential new Client indicates that they received the recommendation and the contact details of Taxcoach sp. z o.o. from a given program participant.

IV. Conditions that must be met for the monetary bonus to be paid

1. The program participant must provide the contact details to Taxcoach sp. z o.o. in accordance with the rules set out above.
2. The potential new Client indicated by the program participant must conclude an agreement with Taxcoach sp. z o.o. for the provision of accounting services.
3. The new Client indicated by the program participant must pay the first monthly subscription fee due as remuneration for the provision of accounting services by Taxcoach sp. z o.o.

4. The period during which the bonus may be paid is 3 months from the date of the recommendation. This means that the bonus will be paid if the new Client indicated by the program participant concludes an agreement with Taxcoach sp. z o.o. for the provision of accounting services within 3 months from the date of the recommendation.

V. Method of bonus payment

1. The one-off bonus shall be paid in full after the new Client indicated by the program participant has paid the first monthly subscription fee due as remuneration for the provision of accounting services by Taxcoach sp. z o.o.
2. The amount of the one-off bonus shall be equal to the monthly subscription fee due as remuneration for the provision of accounting services by Taxcoach sp. z o.o. to the new Client indicated by the program participant. The amount stated on the invoice issued by the referring party shall be the gross amount equal to the net amount of the subscription fee of the referred Client.

VI. Organizer and Administrator of the program

The Organizer and Administrator of the program is Taxcoach sp. z o.o.

1. Any disputes and matters not covered by these Terms and Conditions shall be resolved by the Organizer of the program.
